## Permanent Tattoo Consent Form

I acknowledge by signing this release form that I have been given the full opportunity to ask any and all questions I might have about obtaining a tattoo from Tattoo Blu LLC. And I agree as follows:

- I am not under the influence of alcohol or drugs. NO PERSON MAY BE TATTOOED WHO APPEARS TO BE UNDER THE INFLUENCE OF ALCOHOL OR DRUGS.
- I have looked at my design, checked the spelling if applicable, and give my full consent to the artist to perform my tattoo.
- I acknowledge that I am not pregnant.
- I acknowledge that I am at least 18 years old or older.
- I acknowledge that Tattoo Blu LLC nor the Artist performing my tattoo(s) is responsible for any allergic reaction I may have to dyes, pigments, or processes used in my tattoo(s).
- I acknowledge that allergic reactions are possible, and I accept the risks.
- I acknowledge that infection is always possible as a result of obtaining a permanent tattoo particularly in the event that I do not take proper care of my tattoo, and I accept the risks, and I understand that Tattoo Blu LLC, nor the Artist shall be held responsible.
- I acknowledge that I will or have been given written and verbal after care instructions.
- I acknowledge that variations in colors and shades may occur to any tattoo and Tattoo Blu LLC nor the Artist shall be held responsible.
- I acknowledge that tattooing is a permanent change to my appearance and no representation has been made to me as to the ability to later change, alter, or remove my tattoo.
- I agree to release and forever discharge and forever hold harmless Tattoo Blu LLC and its Artists, Associates, Agents, and any other stake holder, from any and all claims, damage, or legal actions arising and/or connected in any way to my services obtained here today including but not limited to my tattoo(s).
- I acknowledge that tattoo inks, dyes and pigments have not been approved by the US Federal Food and Drugs Administration, and the health consequences of using these products are unknown.
- I acknowledge that there is a chance I might feel lightheaded, dizzy, or otherwise ill during or after being tattooed. I agree to immediately notify the Artist if this happens during my tattooing. And it is up to the Artist discretion to continue service, and Tattoo Blu LLC nor the Artist are in any way responsible.
- I agree to follow the instructions of aftercare as advised by the Artist, and any touch-ups needed because of my own negligence will be done at my own expense.
- I understand the risks of tattooing to include but not limited to infection, scarring, allergic reactions, or anything else, and I still like to proceed with this service, and I assume full responsibility.
- I understand that I may qualify for a free touch up within 3 months after my tattoo is done, although it is up to the discretion of the Artist, and I must have followed the aftercare instructions accordingly.

You are hereby notified of the possible risks and dangers associated with the application of each tattoo. These risk and dangers include, but are not limited to, at least the following:

- the possibility of discomfort or pain;
- the permanence of the markings;
- the risk of infection; and
- the possibility of allergic reaction to the pigments or other materials used.
